Adoptive Family Support Services are available to adoptive families who are in the process of finalizing or have finalized an adoption for a child or youth from the SCDSS Foster Care System. All services are provided using the model of Trust Based Relational Intervention®.

Services are provided on a sliding scale of intervention, based on the needs of the family.

- Adoptive Family Support Groups
- Family Training and Coaching
- Crisis Consultation

Flourishing Families of SC, in collaboration with South Carolina Department of Social Services, is hosting a two-day training, Meet the Need: South Carolina's Statewide Training on Adoption. Meet the Need 2023 offers two days of trauma-focused attachment-based training for up to **400 attendees**. The focus of this year's training is to increase our capacity and competence in meeting the complex needs of our children as *adoptive parents, adoption professionals, clinicians, legal professionals, and state agency leaders*.

The training features keynotes and breakout sessions led by nationally known experts in the adoption field including Katie Rinaudo from the Karyn Purvis Institute for Child Development, Nicole Coning of Harmony Family Center, Trent and Pam Taylor of Watch Me Rise, and Thompson Dove Law Group.

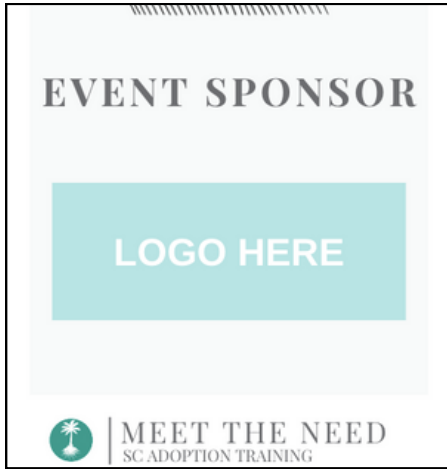

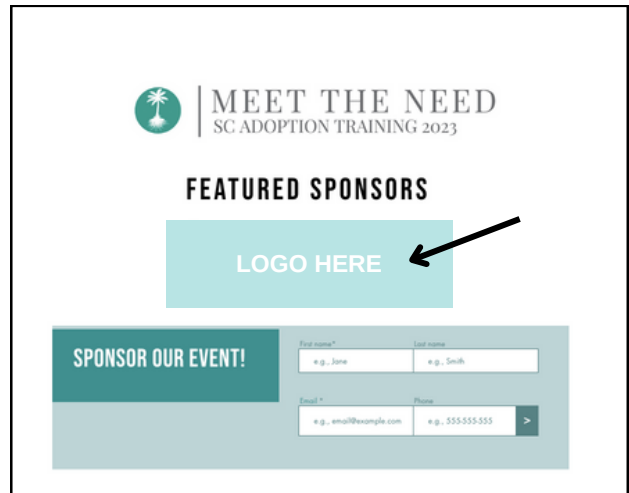

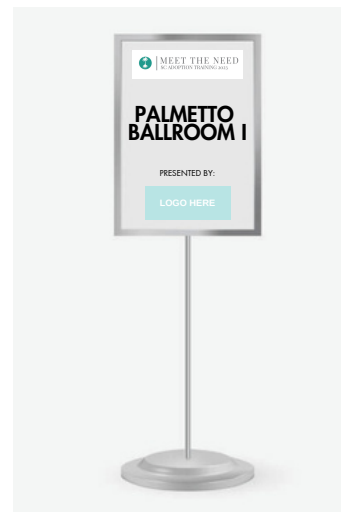
